What perspectives and skills and experiences will you bring to this position? MAC recently participated in a summit at SAA's annual meeting of national and regional organizations. Attendees discussed ways in which regionals across the country could work more closely together on a number of fronts involving advocacy, education, and resource and information sharing. What do you see as the priorities for such discussions and future collaboration?

Since MAC's membership and leadership come from diverse repositories and a wide geographic range, collaboration is critical in representing the interests of members and fostering professional growth. My strength as a collaborator and my keen sense of MAC's role in facilitating that collaboration will serve our organization well. As an educator, I understand the needs of new professionals; as a practitioner, I experience the ongoing needs of mid-career archivists. My involvement with multiple committees has allowed me to collaborate with professionals throughout the MAC region. I've worked with the Education Committee to develop the Speaker's Bureau. As a member of multiple program committees, I've encouraged strong professional programming for a broad constituency. As an editor for MAC's publications, I understand the importance of communication in professional advocacy, education, and resource sharing. All of these will be priorities for me as MAC's President.

The incoming president's priorities will necessarily be driven by the changing interests of membership and the resources of the organization, but collaboration is necessary for success. MAC must leverage its resources to support initiatives such as the Speaker's Bureau, professional education opportunities at the annual meeting and symposium, and a strong publications program. However, it's equally important to engage our members in the discussion of broader issues. I see the SAA/Regional Summit as an excellent way to engage the entire MAC membership, and I support its continuation. I would make the Summit a topic of discussion at the MAC Annual meeting, setting up a session to engage MAC leadership with members. It is also critical to engage students and new professionals in all levels of discussion, and I will seek out ways to draw priorities from these members, as well as engage them in collaborative opportunities supporting MAC.

The President is the principal executive officer of the Midwest Archives Conference and performs all duties usually associated with the office and as enumerated in the parliamentary authority and such other duties as prescribed by Council. What perspectives and skills and experiences will you bring to this position? MAC recently participated in a summit at SAA's annual meeting of national and regional organizations. Attendees discussed ways in which regionals across the country could work more closely together on a number of fronts involving advocacy, education, and resource and information sharing. What do you see as the priorities for such discussions and future collaboration?

MAC's 40th anniversary in 2012 reminds us of the durability and vitality of our organization. It also reminds us that MAC remains relevant by being responsive to the ever-changing needs of our profession. The summit at SAA's annual meeting in San Diego is intended to help MAC and other regional organizations accomplish just that.

Recommendations released in October following the summit may, if implemented, pave the way toward greater collaboration among the local, state, and regional organizations on several fronts, driven by a desire to share and maximize resources. While advocacy, continuing education, and information sharing are cited as significant areas to explore for further collaboration, I believe that enhancing opportunities for continuing education emerges as a priority for MAC's members, as articulated in the MAC Strategic Plan, 2011–2015, and reflected in surveys and from talking with our members.

As chair of the Membership Committee, I have met with new and long-time members over the past four years, engaging in conversations which often turn to the ongoing need for professional development, whether offered on-line or on site, as an in-depth symposium or as a two-hour workshop. The evolving landscape of outreach, for example—with the proliferation of social media, crowdsourcing, and other activities—warrants ongoing review, as do other aspects of our work: description, access, born-digital asset management, collection processing, and legal issues. The Education Committee recognizes this need and has taken steps to establish a speaker's bureau, with other initiatives under consideration. The impact of these and other efforts can be maximized when we collaborate with other entities.

An important caveat: These initiatives will require MAC to improve its financial footing before it can offer such programs. I support the proposal to increase membership dues to help sustain our current and proposed services. MAC dues have not been adjusted since 2001; rising costs over the past decade merit the proposed increase.

If elected, I look forward to working with Council and members as well as representatives of SAA and other regional organizations to ensure a responsive, relevant MAC. Thank you for your consideration.

The Secretary is the recording officer of the Conference and an important communicator among MAC's leadership. The officer is responsible for keeping and transmitting all official minutes and otherwise keeping officers and members apprised of all MAC's official business. What perspectives and skills and experiences will you bring to this position? MAC's marketing and on-line publication task forces are working on new promotional materials and investigating ways to more effectively communicate with members. What do you see as the priorities for these initiatives?

The secretary works effectively with other officers and Council members to ensure that MAC remains a vibrant and financially strong organization that offers members opportunities for continuing education, professional networking, and volunteerism. As a current member of Council, I have a firm grasp of the issues currently facing MAC. I would provide continuity of leadership as MAC develops new educational offerings (e.g., the Speakers Bureau), explores the potential for partnering with other regional associations and SAA, and balances growth with cost-saving measures.

In winter 2012, MAC held its first on-line election, and the 2013 membership renewal drive includes an option for members to "go green" by opting to receive publications electronically. In the future we will surely see an increase in the electronic delivery of services and content—driven partly by budgetary realities of printing and mailing paper materials—and the secretary can help ensure that member input informs future decisions in this area. As more content goes on-line, we should consider how it could be communicated more effectively, perhaps via blogs or other social media. MAC has recently undertaken two exciting initiatives to promote its products and services to archivists outside the region and to allied professionals. Both extend MAC's brand promise of low-cost, high-quality educational offerings and membership services to new audiences. It will be important for the secretary with Council to monitor the progress of these campaigns and assess their success.

Another critical role for the secretary in the near term will be developing a procedure for the routine transfer of electronic records to the MAC archives at the University of Wisconsin–Milwaukee. Material that exists on the Web, in member forums, and other locations needs to be brought together with the rest of MAC's history.

I appreciate the opportunity to run for secretary and am excited by the prospect of helping to lead MAC into the future.

My experience in leadership positions within SAA and nonarchival groups has given me the skills to serve as MAC secretary. I am honored to be a candidate for MAC's Council. My past professional leadership positions in MAC as well as my experiences in regional and national organizations will assist me in understanding the policy questions and operational activities I as a council member will face. As MAC moves forward, I can provide leadership in these areas as a council member that allow for MAC to better support all of its members, both on-line and off, and make it an even stronger professional organization.

The strength of MAC as an organization comes from not only the variety of archivists and archival repositories it represents, but also from the willingness of its members to contribute their time and talents to its various councils, committees, and task forces. From my own experience in MAC, I have found that bringing together individuals from different repository types (corporate, academic, religious, government, and more), perspectives (lone arrangers and those from large organizations), and experience levels (new and experienced professionals) contributed to more successful and informed outcomes.

The role of the Nominating Committee is to recruit candidates for office who are passionately committed to making a reality MAC's mission, goals, and strategic directions. The selection of diverse and effective leaders who can balance the need to take risks with protecting the long-term viability of the organization will sustain and build the organization in the long term. In the recruitment process, committee members must also be mindful to identify candidates with strong leadership, management, and communication skills who can work in a team environment.

How do I see the Nominating Committee achieving this goal? A good starting point for the committee is to target members to run for office who have proven track records as leaders in MAC and other archival organizations in our region. The committee should also seek out individuals from our ranks who are interested in new challenges and who aspire to greater leadership roles in the organization. But even more importantly, we should actively listen to and consult our membership. Their recommendations can greatly aid us in identifying individuals who would bring different skill sets and points of view to the table—including members new to the profession or region and from diverse social and cultural groups. It is my belief that by presenting a mix of seasoned leaders and new faces as candidates for office, MAC will be well served in the future.
